5. The total amount of time expended on this litigation by my firm is 200.6 hours. The total lodestar for my firm is \$ 54,867.50.


6. My firm's lodestar figures are based upon the firm's billing rates, which rates do not include expense items. Expense items are billed separately and such charges are not duplicated in my firm's billing rates.

7. As detailed in Exhibit 2, my firm has incurred a total of \$ 0 in unreimbursed expenses in connection with the prosecution of this litigation.
